SUMMARY OF EXPERIENCE AND ACCOMPLISHMENTS

Mr. Haney raised approximately \$100 million in support of the Federation's international market development and trade advocacy programs during his 20-year tenure with the Canada Beef Export Federation. Under his leadership, Canadian beef and veal annual exports to Asia and Mexico rose from \$25 million in 1992 to \$500 million in 2002. Mr. Haney served as primary industry spokesman during the two years following the diagnosis of BSE in Canada; supporting consumer and industry confidence through clear and factual communication. Canadian beef and veal exports recovered from \$214 million in 2003 to \$405 million in 2010.

Mr. Haney provided general management to the Federation's seven offices in Canada, Asia and Latin America. Mr. Haney maintained close liaison with the Federation's elected Board of Directors and general membership. He has had extensive domestic and international experience completing business evaluation of agri-food ventures, farm management, rural appraisal, and economic analysis assignments. Mr. Haney has extensive international business experience, and is able to function in a variety of cross-cultural settings.

SELECTED ASSIGNMENTS

Developed multi-year coordinated market development strategies for the Canada Beef Export Federation. Based on the strength of these strategies, the Federation attracted over \$8 million in annual private and public funding. These funds were used to conduct generic and branded beef promotions in priority geographic markets. Canadian beef exports to Asia and Mexico increased from \$25 million in 1992 to \$500 million in 2002. Access was regained to over 70 international markets by 2006. Export sales have increased from \$214 million to \$405 million from 2003 through 2010.

Developed critical market access and public communication strategies with industry and government partners in the face of Canada's BSE trade crisis. Served as a primary spokesperson for the Canadian cattle/beef industry, completing over 2,000 media interviews regarding the impact of BSE on the Canadian cattle and beef industry from 2003 to 2005.

Developed the Canadian beef and veal market in Russia from 2008 to 2011. Necessary contacts were developed with key contacts from Russia's government, industry and trade associations. Canadian beef and veal exports rose from \$5 million in 2008 to \$24 in 2010. The Canadian beef and veal industry subsequently established to goal of further increasing exports to this market to \$50 million by 2020.

Provided overall management for the Canada Beef Export Federation's Calgary, Tokyo, Seoul, Taipei, Hong Kong, Shanghai, and Monterrey offices. This included management of program planning and implementation, staff resources, and financial controls. This management ensured that programs were matched to the exporting interests of the Canadian beef industry. Sound fiscal management was also achieved.

Conducted market development programs on behalf of Canada's cattle and beef industry in Japan, South Korea, Taiwan, Hong Kong, China, and Mexico. As a result of these promotions, and linkage with Canadian beef exporters, major sales and market share gains were produced in Asia and Mexico.

Conducted trade access negotiations with Chinese (People's Republic) officials on behalf of the Canadian beef industry. As a direct result of these negotiations, Canada's major beef processors were registered for direct export to the PRC. This market access is preferential to all other major beef exporting nations.

Conducted trade access negotiations with Korean officials on behalf of the Canadian beef industry. As a direct result of these negotiations, Canada's three high-quality beef grades was granted preferred access under Korea's import regulations.

Conducted trade access negotiations with Taiwanese officials on behalf of the Canadian beef industry. As a direct result of these negotiations, over twenty percent of Canada's beef production has been granted preferred access under Taiwan's import regulations.

Opened international offices for the Canada Beef Export Federation in South Korea, Taiwan, Hong Kong, China, and Mexico. Staff selection, administration planning, and strategy development were all completed in cooperation with the Federation Executive Committee. Organized and led Asian regulatory and commercial missions studying the Canadian cattle and beef sectors. Missions were led for Agriculture Canada, Foreign Affairs and International Trade Canada, and the Canada Beef Export Federation.

Developed a multi-layer internet web site (http://www.cbef.com/) for the Canada Beef Export Federation. This web site offered a wide range of industry and membership information.

Developed the study methodology and implemented the National Beef Export Study in order to monitor the expansion of designated regional beef export market shares for the Canada Beef Export Federation.

Developed international agriculture trade policy for the Calgary Chamber of Commerce as the International Trade Expert for the Chamber's Agri-Bureau, and as a member of the International Trade Committee. Chamber positions have been developed and presented to foreign trade and diplomatic representatives.

Chaired the Agriculture Canada Western Red Meat Team which produced a regional strategy for Agriculture and Agri-Food Canada, in the development of the Western Canadian beef and pork sectors.
